2. A short *prose paragraph* (200–300 words) in which you briefly explain your thesis *topic*, your provisional *thesis statement* and the *methodology* which you will use.
3. A provisional *bibliography* of primary (if applicable) and secondary sources, formatted according to the MLA or APA (or Chicago/Turabian) style-sheet (depending on your specialization).

Further explanation

Your *thesis topic* should clarify what phenomenon you are going to examine in your MA thesis and why. You should clarify the overall *analytical claim* which you are going to make (the core of our analytical argument, so to say). Your *methodology* should clarify the theoretical models or approaches on which you will draw in examining your thesis topic.
