Parties agree on the following:
Article 1
Period The traineeship runs from/(day, month, year) to/(day, month, year).
Article 2
The traineeship provider enables the trainee to carry out work within the framework of the study of Public Administration.
The trainee will not undertake any activities lying outside the framework of the subject of the traineeship. The traineeship provider will permit the trainee to undertake activities for the benefit of the trainee's graduation project.
Article 3
The traineeship will be fulfilled under responsibility and supervision of the Institute of Public Administration, Leiden University.
Article 4
The traineeship provider assigns a supervisor who, together with the traineeship coordinator of the Institute of Public Administration, will be responsible for the supervision of the trainee.
Article 5
The daily learning time is in accordance with the working hours that apply to the organization

where the trainee will perform his/her activities, unless other arrangements have been made.

# Article 6

The trainee must comply with the instructions, rules, and regulations applying to the personnel of the traineeship provider for the sake of order, safety and health.

# Article 7

The traineeship provider is, after consultation with the Institute of Public Administration, authorized to terminate this contract, if the trainee has not complied with the instructions or regulations of the supervisor in the opinion of the traineeship provider.

### Article 8

The trainee is obliged to keep secret those matters which he/she is confided in during the traineeship, and those matters which he/she has the disposal of and of which the confidential nature is to be (implicitly) understood.

### Article 9

In case of illness the trainee informs both the administrative Institute of the traineeship provider and the traineeship supervisor.

### Article 10

# Article 11
